## Housekeeping Reminders

**Trash containers** must be stored where they are not visible from the street. Containers stored in front of garage doors are unsightly. We ask for your cooperation in complying with the spirit and intent of our Rules & Regulations.

**Basketball stands** should not be left in the street or where they block the sidewalk. The City of Poulsbo has started clamping down on this because of the many complaints they are receiving.

## Crystal View Impact on Deer Run

Deer Run residents will see some sewer construction and possible truck traffic as a result of the neighboring Crystal View development. The 12.14-acre development shares a border with four Deer Run residents on Miss Ellis Loop, and will include 46 homes.

The developer purchased a 15-foot easement from a Deer Run resident so 10 of the new homes in Crystal View can link to the sewer line on Miss Ellis Loop. We don't know when this sewer line construction will take place; but the City of Poulsbo has assured us that the construction will not block emergency vehicles.

Crystal View is eventually supposed to have a second entrance

on the proposed Johnson/Noll Road extension to Route 305; but it may be five years or more before that entrance road is ready for truck traffic. In the meantime, Sunrise Ridge Ave. NE in Meredith Heights provides Crystal View's only access for trucks and construction equipment. Although most of the traffic will use Hostmark, Deer Run may see some additional traffic. Many already use Deer Run as a short-cut between Noll Road and Caldart. If this becomes a problem we will file formal complaints with the City of Poulsbo.

The Crystal View developer plans to remove the trees that overlook Miss Ellis Loop along its border. At a public hearing, Deer

Run and Meredith Heights residents raised concerns about the effects on the stability of the steep slope behind them and seepage from the exposed aquifer. The developer assured the Hearings Examiner and adjoining residents that suitable measures will be taken to stabilize the slope and divert seepage and run-off into a storm-water retention basin located well away from the border. However, the existing "greenway" will be clear-cut.

The Crystal View proposed plat plan (originally called "Crystal Glen") was first submitted on June 22, 2009, and is therefore subject to the zoning, critical areas and building restrictions in effect at the time, rather than the 2013 revised standards.

## Roundup Weed Killer - Gene Bullock

Aerial spraying of Roundup in Hansville by Pope Resources has prompted strong community opposition because of possible harm to surrounding residents. According to research funded by Monsanto, the company that makes Roundup, the main ingredient, glyphosate, does not harm birds, wildlife or humans. Both the U.S. Environmental Protection Agency (EPA) and the European Food Safety Authority (EFSA) found that glyphosate was probably not carcinogenic.

Nonetheless, in 2015, the International Agency for Research on Cancer (IARC), an arm of the World Health Organization, classified glyphosate as "probably carcinogenic

in humans," even while noting that there was "limited evidence" of a link between glyphosate and non-Hodgkin lymphoma. Based on the IARC classification, several counties now ban its use.

IARC researchers cited animal studies – specifically, studies of mice and rats – that demonstrated a possible link between glyphosate and cancerous tumors; and laboratory studies that showed the weed killer can damage DNA in human cells.

In one metropolitan study of the effects of herbicides and pesticides on children, 99% of the children tested had traces of these chemicals in their tissues.

The claim that glyphosate causes cancer has led to the filing of hundreds of Roundup lawsuits in state and federal courts across the United States. In August 2018, a California jury awarded a former school groundskeeper \$289 million in compensatory and punitive damages.

The use of Roundup is widespread among farmers, groundskeepers, gardeners, tree farms, and highway and parks maintenance operations. While it does not appear to kill birds and wildlife, it has been devastating to Monarch butterflies, because its wide use is eliminating milkweed and other wild plants essential to their reproduction and survival.

# Indoor Cats Live Twice As Long

People who care about cats recognize that it's not ideal to allow cats to roam. Outdoor cats live less than half as long as indoor cats on average. Outdoor cats live short lives characterized by hardship, disease, and injury. Cats suffer when they are hit by cars, injured or killed by predators or other cats, or contract diseases. Outdoor cats also transmit diseases such as toxoplasmosis to humans and to wildlife including sea otters and Hawaiian monk seals.

Free-ranging cats also take a devastating toll on birds and other wildlife. These are non-

native predators that, even using conservative estimates, kill 1.3–4 billion birds and 6.3–22.3 billion mammals each year in the U.S. alone (*Loss et al. 2013, Nature Communications*).

For small dogs and cats, outdoor predators include foxes, coyotes and Bald Eagles. Even raccoons can be dangerous to pets who threaten their young. Obviously, both cats and wildlife are far safer when cats are kept indoors.

## Catios the Cat's Meow

Catios (cat patios or outdoor enclosures) are growing in

popularity among owners who want their pets to be able to enjoy being outside in complete safety. Catios can range from screened window boxes to fenced enclosures to fashionable screened-in rooms. A variety of models are commercially available, but many homeowners chose to build their own.
